

Inflation falls to 4.0% in October

Consumer Prices in October, as measured by the CPI, decreased by 0.2% in the month. This compares to an increase of 0.1% recorded in October of last year. As a result, the annual rate of inflation fell to 4.0%, down from 4.3% in September 2008.

The most significant monthly price changes were decreases in *Clothing & Footwear* (-2.0%), *Transport* (-1.8%), *Health* (-0.6%) and *Furnishings, Household Equipment & Routine Household Maintenance* (-0.5%). There were increases in *Education* (+3.6%) and *Miscellaneous Goods & Services* (+1.3%).

The most notable changes in the year were increases in *Housing, Water, Electricity, Gas & Other Fuels* (+11.5%), *Education* (+6.2%), *Health* (+5.6%), *Alcoholic Beverages & Tobacco* (+4.8%) and *Food & Non-Alcoholic Beverages* (+4.6%). There were decreases in *Clothing & Footwear* (-6.8%) and *Furnishings, Household Equipment & Routine Household Maintenance* (-1.6%).

The annual rate of inflation for Services was 5.9% in October, while Goods increased by 1.8% in the year.

This release provides a detailed analysis of the major price developments within the main CPI commodity groups in tables 1 to 17. Also included is Table A, which compares the contributions towards the annual rate of inflation for the current month with the corresponding period last year.

Note For Table A

The annual rate of inflation for October 2008 was 4.0%. The annual rate of inflation for the same period last year was 4.8%. The primary factor contributing to the difference in the annual percentage changes for October 2007 and October 2008 was the decreasing contribution of *Water, Electricity, Gas and Other Fuels*. Other factors contributing to the index changes were decreases in *Restaurants and Hotels* and *Clothing and Footwear*.

Inflation for goods decreased from 2.1% in the year to October 2007, to 1.8% in October 2008. Inflation for services fell from 7.3% in the year to October 2007, to 5.9% in October 2008.



01 Food and Non-Alcoholic Beverages




01 Food and Non-Alcoholic Beverages

Food & Non-Alcoholic Beverages prices decreased by 0.1% in the month and increased by 4.6% in the year to October 2008. This compares to an increase of 4.4% for the year to October 2007.

In the month, food prices decreased by 0.1% while non-alcoholic beverages prices decreased by 0.2%. In October, price decreases were recorded for cheese (-3.8%), pork (-3.7%), potatoes (-3.5%), other bread & cereals (-2.9%), other cereals (-2.6%), soup (-1.2%), bread (-0.9%), condiments & sauces (-0.9%), fresh fruit (-0.8%) and preserves (-0.7%). Price increases were recorded for fresh fish (+3.2%), other fresh vegetables (+2.5%), beef (+1.7%), lamb (+1.6%), margarine & low fat spreads (+1.1%), coffee (+0.9%), cakes (+0.8%), flour (+0.8%) and other oils & fats (+0.8%).




02 Alcoholic Beverages and Tobacco

Overall prices increased by 0.2% in the month and by 4.8% in the year to October 2008. This compares to an increase of 5.4% for the year to October 2007.

In the month, alcoholic beverages prices decreased by 0.1% while tobacco prices increased by 0.4%. Price increases were recorded for beer (+2.6%), wine & cider (+0.6%) and cigarettes (+0.4%). A price decrease was recorded for spirits (-5.0%).

03 Clothing and Footwear




03 Clothing and Footwear

Clothing & Footwear prices decreased by 2.0% in the month and by 6.8% in the year to October 2008. This compares to a decrease of 3.5% for the year to October 2007. In the month, clothing prices decreased by 2.3%, while footwear prices decreased by 0.2%.

In the month, price decreases were recorded for garments (-2.4%), other articles of clothing (-1.1%) and shoes & other footwear (-0.2%). Price increases were recorded for dry cleaning & laundry (+0.6%), repair & hire of footwear (+0.4%) and dress hire & repair of clothing (+0.2%).



04 Housing, Water, Electricity, Gas and Other Fuels

Housing, Water, Electricity, Gas & Other Fuels costs decreased by 0.2% in the month and increased by 11.5% in the year to October 2008. This compares to an increase of 17.4% for the year to October 2007.

In the month, price decreases were recorded for liquid fuels (i.e. home heating oil) (-11.0%) and materials for the maintenance & repair of dwelling (-0.2%). Price increases were recorded for solid fuels (+6.2%), bottled gas (+2.5%) and mortgage interest (+0.4%).




05 Furnishings, Household Equipment and Routine Household Maintenance

Furnishings, Household Equipment & Routine Household Maintenance costs decreased by 0.5% in the month and by 1.6% in the year to October 2008. This compares to a decrease of 2.3% for the year to October 2007.

In the month, price decreases were recorded for carpets & other floor coverings (-3.2%), household textiles (-3.1%), glassware, tableware & household utensils (-2.0%), furniture & furnishings (-0.6%), small electric household appliances (-0.5%), small tools & miscellaneous accessories (-0.3%) and major household appliances (-0.2%). Price increases were recorded for non-durable household goods (+0.3%) and major tools & equipment (+0.2%).




06 Health

Overall health costs and charges decreased by 0.6% in the month and increased by 5.6% in the year to October 2008. This compares to an increase of 3.0% for the year to October 2007.

In the month, price decreases were recorded for hospital services (-2.1%) and other medical products (which includes condoms, petroleum jelly, disinfectant & adhesive dressing) (-0.7%). A price increase was recorded for other medicines (which includes pain relievers, antacid, cough mixture, vitamins & other supplements) (+0.4%).


07 Transport



07 Transport

Transport costs decreased by 1.8% in the month and increased by 3.0% in the year to October 2008. This compares to an increase of 3.1% for the year to October 2007.

In the month, price decreases were recorded for diesel (-5.2%), petrol (-5.0%), air transport (-4.0%), sea transport (-3.8%), other vehicle costs (which includes parking fees and car rental charges) (-0.6%) and motor cars (-0.3%). Price increases were recorded for motor oil (+1.2%), bus fares (+0.4%), rail transport (+0.4%) and bicycles (+0.3%).



Overall communication costs decreased by 0.1% in the month and increased by 0.9% in the year to October 2008. This compares to an increase of 1.2% for the year to October 2007.

In the month, a price decrease was recorded for telephone and communication services (-0.2%).




09 Recreation and Culture

Overall prices increased by 0.3% in the month and by 1.4% in the year to October 2008. This compares to an increase of 1.1% for the year to October 2007.

In the month, price increases were recorded for television services (+1.9%), recording media (+1.9%), stationery (+0.9%), newspapers & periodicals (+0.8%) and pets & related products (+0.3%). Price decreases were recorded for information processing equipment (-3.0%), photographic & cinematographic equipment & optical instruments (-1.9%), equipment for the reception, recording & reproduction of sound & pictures (-1.9%), games, toys & hobbies (-0.9%) and gardens, plants & flowers (-0.9%).





Education costs increased by 3.6% in the month and by 6.2% in the year to October 2008. This compares to an increase of 5.2% for the year to October 2007.

In the month, price increases were recorded for primary education (+7.6%), second level education (+7.1%), third level education (+5.3%) and other education & training (+0.8%).



Prices for the overall category increased by 0.1% in the month and by 2.9% in the year to October 2008. This compares to an increase of 4.0% for the year to October 2007.

In the month, price increases were recorded for canteens (+2.2%), beer (+1.1%), soft drinks & mineral water (+0.7%), spirits (+0.6%), wine & cider (+0.5%) and restaurants, cafes & fast food (+0.2%). A price decrease was recorded for accommodation services (-3.6%).



12 Miscellaneous Goods and Services

12 Miscellaneous Goods and Services

Overall prices increased by 1.3% in the month and by 2.1% in the year to October 2008. This compares to an increase of 1.0% recorded for the year to October 2007.

In the month, price increases were recorded for dwelling insurance (+7.3%), childcare (+5.4%), other social protection (which includes nursing home costs) (+2.1%), toilet accessories (+1.3%), other personal grooming (+1.2%), hair products (+0.3%), cosmetics & skincare products (+0.2%) and financial services (+0.1%). Price decreases were recorded for other personal goods (-2.5%), hygiene products (-1.1%), electric appliances for personal care (-0.3%), hairdressing (-0.1%) and jewellery, clocks & watches (-0.1%).

Background Notes – Consumer Price Index

Definition The Consumer Price Index is designed to measure the change in the average level of prices (inclusive of all indirect taxes) paid for consumer goods and services by all private households in the country and by foreign tourists holidaying in Ireland.

Consumer Price Index (CPI) Over 50,000 prices are collected for a representative basket consisting of 616 headings which cover over 1,000 different items in a fixed panel of retail and service outlets throughout the country on the second Tuesday of each month. The date to which the October index relates is Tuesday, 14th October 2008.

- Scope of the Index**
- (i) Population Coverage: All private households in the state and the expenditure of foreign tourists within Ireland. It does not include the expenditure of persons in institutions and other non private households. Expenditure which occurs abroad by Irish residents is also excluded. In statistical terms coverage is referred to as the domestic concept.
 - (ii) Geographic Coverage: Covers the whole of the Republic of Ireland. Pricing takes place in Dublin and 83 other locations (cities and towns) throughout the country. These sampling points are located in Dublin city and county, the four regional cities of Cork, Limerick, Galway and Waterford, approx. 80% of towns with a population of 10,000 and over, approx. 70% of towns between 5,000 and 9,999 and a smaller proportion below this threshold. The results are weighted to represent the distribution of the population and its related consumer expenditure. The sample is organised on a regional basis for calculation purposes.
 - (iii) Item Coverage: All goods and services bought by the reference population for the purposes of consumption are included in the index. Expenditure on capital assets and investments, gambling and certain other activities are however excluded. Over 1,000 different varieties are priced and then aggregated into 616 item headings and 12 group headings based on the COICOP classification. With each rebase the coverage of goods and services is reviewed to ensure that it continues to be representative of consumer tastes and purchasing practices.

Price Collection Personal visits are made to retail outlets by some 200 part-time pricers on a monthly basis. Approximately 50,000 price quotations are gathered in this way. In addition, 114 special inquiries covering items such as utility charges and services are conducted by post and telephone. Most prices are collected monthly, some quarterly and others annually. The CSO supplies general specifications to price collectors and collectors are free initially to select a brand and in certain cases, size. This allows for a wide variety of different brands of the same item to be priced throughout the country. Once selected, the same item/brand is priced on a monthly basis in order to ensure matched price quotations. If an item disappears, substitution can occur but that price is excluded until matched prices are available for the same comparable item for two consecutive months. The CSO wishes to put on record its appreciation of the co-operation and assistance it receives from retail outlets and other business concerns.

CPI Weights The CPI measures in index form the monthly changes in the cost of purchasing a fixed representative ‘basket’ of consumer goods and services (i.e. Laspeyres formula). The representative share of each item in this basket is proportional to the average amount purchased by all households in the country as determined by the Household Budget Survey and by foreign tourists in this country using estimates of expenditure by tourists across a range of consumer goods and services. Individual items typically purchased by foreign tourists while holidaying in Ireland such as hotel accommodation and meals out have been adjusted to take account of the additional tourist expenditure. Identical items are priced in the same outlet on each occasion so that changes in the cost of this constant basket reflect only pure price changes.

Background Notes – Consumer Price Index (continued)

Rebase The index has been rebased with effect from December 2006, the tenth series since the foundation of the State.

The rebase of the current CPI resulted in a number of methodological changes:

- Updating the expenditure weights;
- A revision of the sample of goods and services;
- An update of the sample of areas priced; and
- A move to a regional structure in the calculation methodology.

Classification The classification used in the CPI is based on a version of COICOP – COICOP HICP, the Classification of Individual Consumption Expenditure by Purpose. This replaced the former national classification which was used up to December 2001. The COICOP classification breaks consumer expenditure into twelve different categories covering a comprehensive range of consumer goods and services. Indices for the previous national classification are no longer published as of December 2006. The data, however, will continue to be made available on the CSO website (www.cso.ie) and by request to the Consumer Prices Section (cpi@cso.ie).

Goods and Services The consumer basket can be split into two constituent parts - goods and services according to the following definitions.

Goods Goods are defined as non service items usually purchased and transportable from a retail outlet - the basket excluding services.

Services Services include electricity, gas, telecommunications and other public utilities, alcoholic beverages consumed on licensed premises, meals out, accommodation services, public transport, medical fees, insurances, education fees, hairdressing & other personal services, childcare & social protection, entertainment & recreation services, mortgage interest & rents, package holidays and other miscellaneous services.

Utilities and Local Charges Includes electricity, gas, landline telecommunications and local authority service charges.

Background Notes – COICOP Classification

Prior to the introduction of the December 2001 based series in January 2002 the CPI used a national classification while the HICP used COICOP/HICP. To ensure greater comparability CPI and the HICP have both used the COICOP/HICP classification since December 2001 (Classification of Individual Consumption by Purpose - adapted for the purposes of the EU HICP).

The COICOP classification is based on 12 main subgroups.

| 01 Food and Non Alcoholic Beverages | Food and non alcoholic beverages purchased in supermarkets, small shops, speciality shops and petrol station forecourt outlets. It excludes meals out which are covered under 11 Restaurants and Hotels. |
| 02 Alcoholic Beverages and Tobacco | Includes alcoholic beverages purchased in off licences and supermarkets but excludes alcohol consumed on or within a licensed premises which is classified under 11 Restaurants and Hotels. |
| 03 Clothing and Footwear | Mens, ladies and childrens clothing and footwear, sports and leisurewear and services such as laundry and dry cleaning, shoe repair, dress hire and alteration. |
| 04 Housing, Water, Electricity, Gas and Other Fuels | This group covers rents, mortgage interest repayments, local authority service charges, goods and services for maintaining, decorating and repairing dwellings and domestic energy products such as electricity, gas and solid fuels. |
| 05 Furnishings, Household Equipment and Routine Household Maintenance | This category covers household items such as furniture, carpets and other floor coverings, house textiles and soft furnishings, household electrical appliances, and other household items such as utensils, tools, garden equipment and non-durable items for cleaning, washing and other day to day household activity. Also included in this category are domestic services such as cleaning and other services. |
| 06 Health | Health includes medical products, appliances and equipment, hospital charges and out patient services supplied by doctors, dentists, opticians and practitioners of alternative and complementary medicine. |
| 07 Transport | Includes the purchase of new and second hand vehicles, spare parts, car maintenance, fuels and lubricants, public transport and services such as parking, motor association subscriptions, car wash, toll charges, driving tests, licences and car hire. |
| 08 Communications | Post and telecommunications. |
| 09 Recreation and Culture | All goods and services connected with recreation and culture and includes items such as audio visual and photographic equipment, computers, music and DVDs, sports and recreation goods, games and toys, items connected with gardening and pets, recreational, sporting and cultural activities and events, newspapers and other reading material, package holidays and other items connected with recreation and culture. |
| 10 Education | Covers all aspects of education including primary, secondary, third level and other education and training such as night courses, play schools and examination fees. |
| 11 Restaurants and Hotels | This category covers the following areas: meals in restaurants and hotels; fast food and takeaways; cafes; canteens; alcohol consumed on or within a licensed premises and accommodation services supplied by hotels, guesthouses and hostels. |
| 12 Miscellaneous Goods and Services | This remaining category covers a wide range of items including hairdressing and other grooming; goods for hygiene, hair and body care; personal goods such as jewellery, handbags and wallets; childcare and other social protection services; insurance, financial services and other services including funerals, weddings, legal and professional services. |
