

#### CSO last developed a long-term strategy, CSO 2020, back in 2013. That strategy laid the foundation for meeting emerging demands in Official Statistics, with an emphasis on quality management and 'getting the basics right'. Much progress has been made under CSO 2020, and as a new decade begins, there is now an opportunity to revisit this long-term vision and to set the direction of travel out to 2030.

A lot has changed since the development of the last CSO vision both in terms of the data environment we operate in and the social and economic impacts of the COVID-19 pandemic.
