## CSO's position in the Irish Data Ecosystem

Good quality data is the foundation of decision making and an essential component in enabling the people of Ireland to live in an informed society Good quality statistics help people to understand the changes taking place in Ireland's economy and society.

The Irish Data Ecosystem comprises the data holdings across the Irish Civil and Public Service. These data holdings offer significant insights for decision makers and the people of Ireland if they are structured and organised according to agreed standards and classifications. Without structure, data is locked in silos resulting in lost opportunities for efficiencies and insight.

The data and services we provide support data integration and enable policy development, policy evaluation and research by others. We provide leadership within the Irish Statistical System, including seconded CSO Statisticians who produce statistics and improve data management across the Civil and Public Service. We are also leading the development of the National Data Infrastructure, which encourages the use of unique identifiers across the Civil

and Public Sector, to allow more efficient management of data and the easier use of administrative data for the creation of Official Statistics.

As the data steward in the Irish Data Ecosystem, a role encapsulated in sections 10(2), 10(3)and 31 of the Statistics Act, 1993, the CSO will influence the improvement of the quality of administrative data sources by developing standards, rules and guidelines to govern the classification, storage and management of data across the Civil and Public Service.

A strong data ecosystem will directly benefit Ireland by:

- Streamlining public interaction with state services
- Underpinning evidence-based policy development and evaluation
- Informing improved service delivery
- Promoting the creation of a robust Public Service
- Providing high quality administrative data for the creation of Official Statistics
